SETTING: The Ben Larson Barn is located on the west side of Nowlens Bridge Road, a quiet, two-lane thoroughfare. The barn is set back from the road, down a unimproved driveway. The site is rolling with many mature trees along the driveway and surrounding the house. Across the road to east is a cultivated field. On the north, south and west are also cultivated fields. The area is predominantly in agricultural uses.

STATEMENT OF SIGNIFICANCE

Historic Name: LARSON, BEN, BARN

The Ben Larson Barn is located along Nowlens Bridge Road, an early 20th century road, approximately one-half mile south of Marquam. The subject property is located within the Robert Allen donation land claim. The resource may be evaluated as an example of an early 20th century barn, and as a component of historic Marquam.

HISTORIC BACKGROUND

SUBJECT PROPERTY

OWNERSHIP

According to county records Ben Larson, the original owner, purchased the subject property in 1910 from O.E.F. Lee. In 1938 Mary B. Larson, a widow, is listed giving a quit claim deed to Eric and Doris Larson, who immediatley sold to Bertha Andahl and others. In that same year Ella Larson Morley, trustee and others also gave a quit claim deed to Bertha Amdahl and others. Bertha Andahl, her husband and others sold the property to Roy and Gertrude D. Morley, who immediately sold to Rex W. and Gladys Ross, who retained ownership until 1961.

HISTORICAL INFORMATION

No biographical information is currently known regarding Ben Larson, Mary B. Larson, Eric and Doris Larson, Bertha Andahl, Ella Larson Morley, Roy and Gertrude D. Morley or Rex W. and Gladys Ross.

ARCHITECTURAL/PHYSICAL INFORMATION

Architectural evidence suggests that the subject barn was built circa 1910. The subject building is an example of the Western Barn type.

The barn has the form and massing characteristic to the style and type. The barn is in good condition. The intersecting gable cupola is a noteworthy feature. Alterations since construction include the addition of a hole in the hay door to allow the entry of an equipment pipe, the removal of several windows and the addition of an opening in the north elevation. The dates of these alterations is currently unknown.

The barn shares the site with several non-historic grain silos, an altered historic dwelling, non-historic garage, non-historic machine shed, non-historic fuel shed and non-historic barn, none of which contribute to the historic character of the subject property.


