DECORATIVE FEATURES: Wide overhanging boxed eaves; cornerboards with caps have the appearance of pilasters; projecting window cornices; two diamond shaped windows on north elevation; front porch with three Tuscan porch columns set on lap sided railing; wood porch decking and steps; single-pane front door; watertable with cap.

EXTERIOR ALTERATIONS/ADDITIONS: Porch stair railing replaced.

NOTEWORTHY LANDSCAPE FEATURES: House set on slight embankment; concrete steps ascend to house; asphalt parking to north of building; railroad tie retaining wall along sidewalk; rhododendrons along front; hedge along neighboring drive to the south.

ASSOCIATED STRUCTURES: None.

SETTING: The building faces east on Northwest 23rd Avenue, a busy two-way arterial. The lot is a moderately sized parcel and is in a primarily mixed use neighborhood. A driveway and parking area are located north of the building. Commercial businesses and residences flank the building.

STATEMENT OF SIGNIFICANCE

Architectural: The Garesche House, constructed in 1905, was designed in the Craftsman/Classic Box style. The house displays characteristics of the style in its hip roof with hipped dormer, rectangular form, cornerboards with caps, wide friezeboard, watertable with cap, full front porch, Tuscan porch posts, lap sided porch wall, and narrow lap siding. In good condition with minor alterations, the house is a good-excellent example of its type. The Classic Box was a popular style in Northwest Portland after the turn of the century.

<u>Historical</u>: The property is associated with the following Portland families or businesses: A. J. and M. M. Garesche, Laura S. Grenier, and George and Rose Vrvilo.

John A. Duncal deeded lots 9-12 to A. J. and M. M. Garesche.

1908 Garesche deeded lot 12 to Laura S. Grenier.

1947 Grenier deeded lot 12 to George and Rose Vrvilo, husband and wife.




