

Historic property is a park with a ciruclar roadway, parking spots, day use areas, and rest facilities. Some stuctures within the park itself are historical, but have undergone maintenance and modification, the extent of which is still being researched. Materials used within the park inlcude cedar shingles, wood siding, brick, and concrete in a rustic design.

The restrooms are the only interiors present at Sarah Helmick State Park and have been updated as needed since construction (circa 1950 and 1970). Restrooms accessed include two stalls and one sink with bare wood walls, exposed beams, and a skylight.				
List known or probable alterations and the approximate date the work was done.				
Based on information from historic aerial photographs and topographic maps, the ciruclation pattern of the park was slightly modified between 1967 and 1972, however this has not changed since 1972. Overnight camping used to be a draw of the park, but declined in the early 1960s and has been day use only since.

Sarah Helmick (neé Steeprow) and Henry Helmick arrived in Oregon in 1845. Emigrating via the Oregon Trail from Burlington, lowa they "took up their own claim on the Luckiamute" (Nesbit 1925) in 1846. With the enactment of the Donation Land Claim Act in 1850, Sarah and Henry were allowed to legally claim their 640 acres in Polk County. Sarah lived on the homestead until she was widowed in 1877, when she moved to 138 Seventh Avenue in Albany. In 1922, Sarah and her son James donated 5.46 acres to the Oregon State Highway Commission "to provide the traveling public a place to rest or stop overnight" (Armstrong 1965). The park's formal dedication ceremony was held on September 12, 1924 and coincided with the completion of the West Side Highway, the paving operations of which had previously blocked access to the park. The Helmick's donation represents the first state park in Oregon.				
Also known as Helmick State Park, the property grew in 1948 through additional land purchases including 23.65 acres which were formerly part of an artillery range at Camp Adair and a donation from William and Mary Weist. An additional 44.6 acres were donated in 1985 by Peter and Maryle Larson. Through additional acquisitions, Sarah Helmick State Park totals 81.72 acres as of 2021.				
Sarah Helmick State Park is Oregon's first of a system that now includes 254 parks on approximately 122,847 acres. From this beginning, Oregon State Parks now serves an estimated 51.7 million day-use visitors and 2.95 million overnight campers. Sarah Helmick State Park represents the earliest days and growth of automobile recreation in Oregon and the beginning of what would become Oregon State Parks.				
Sarah Helmick State Park is potentially eligible for listing in the National Register of Historic Place as a site significant at the state level under Criteria A for its association with recreation, specifically automobile tourism, in Oregon. The property retains integrity of location, setting, association, and feeling. There are certainly historical elements of the park remaining, however to what extent, is still a research question in progress. Integrity of design, workmanship, and materials may still be relatively intact and additional research will offer more insight. The circular road, parking areas, stove shelters, picnic tables, picnic areas, and swimming beach are historical features of the park that, although they have undergone maintenance and modification, still convey the intended use of the property as a place to rest and retreat from the "broiling sun" allowing "the shade trees of the park show to full value" (The Capital Journal 1924).



HONOR IS DONE TO DONOR OF PARK IN SPITE OF ABSENCE

Because it was considered inadvisable for her to make the trip, Mrs. Sarah Helmick was not present at Independence Friday to attend the dedication of Helmick Park upon the occasion of the completion of the west side Pacific highway. Mrs. Helmick was to have received in person the chief honors of the occasion, but it was finally decided that her extreme age. 101 years, would make the trip to Monmouth too hazardous. The celebration at Helmick park

included sports in the morning: a barbecue at noon, and the following afternoon program:

1:30 n. m .- Drill by Company M,

0. N. G., of Corvalis. 2:00 n. m.—Fing Raising by Am-erican Legion post. No. 33 of Indenendence. Star Spangled Banner by Corvillis band. Pledge and Creed to our country.

2:30-Music by Independence Boys hand. Presentation of Park by Frances Helmick, Hill, Albany. Accentance of Park by Governor Walter M. Pierce. Presentation of Testimonial to Mrs. Sarah Helmick. Music by Corvallis band. Greetings by Monmouth Commercial Club. Resnonse by Corvallis and McMinnville Chambers of Commerce. Music by Independence band. Song by Audience. Obsequies of "Old Man Detour". Music by bands.

STATE ACCEPTS HELMICK TRACT FOR AUTO PARK

Monmouth, Sept. 13 .- The completion of the last link of the west side branch of the Pacific highway was celebrated yesterday at Helmick park, four miles south of Monmouth, on the banks of the Luckiamute river.

Coincidental with the formal opening of the highway to traffic was also the dedication of Helmick park, a tract of several acres presented to the state by Mrs. Sarah Helmick, a pioneer, it being a part of the Helmick donation land claim, taken in 1848.

The celebration was under the auspices of the Monmouth commercial club. Large delegations were present from all the west side towns and surrounding country. A large delegation came from Corvallis, led by the commercial club of that city.

The exercises opened with the removal of the barrier, which has confronted travel for a long time and the burial of Old Man Detour in the placid waters of the Luckiamute.

The remainder of the forenoon was given to sports and music by the bands. At noon a free barbecue was enjoyed.

In the afternoon came the formal dedication of the seven-acre park, made by Frances Helmick Hill in behalf of her mother, Mrs. Sarah Helmick, a centenarian. On behalf of the state the park was accepted by Governor Pierce.

J. S. Landers, president of Oregon Normal school, was master of ceremonies.

The completion of the highway marks the end of a long period of construction, attended by considerable controversy and litigation over the location of the highway through Polk county, all of which is now laid aside and being forgotten. It also denotes the end of the improvement of the state highway system in the Willamette valley.
