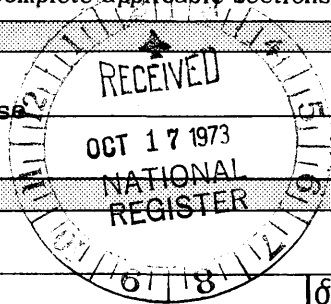

DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The Jacob Conser House, located on the Sanitam River sixteen miles south of Salem, is currently the Jefferson City Hall. Built in 1854 in the Classical Revival Style, the house is situated in the center of a long, un-interrupted block in the heart of the small town of Jefferson. The grounds are informal and well maintained. The building was included in the Historic American Buildings Survey in 1934.

The one and a half story gable-roofed house has an L-shaped plan which provided two separate and distinct areas. The area on the north side had the larger of the two parlors, three bedrooms on the first floor, and two bedrooms and a dormitory area on the second floor. The south side of the house had the kitchen and dining room, a parlor, three smaller rooms on the first floor and a large room on the second floor. Reportedly, the large room on the second floor was used as a meeting room, dance hall, and hotel space during the high point of stagecoach travel. Access to either area was through doors in the recessed front portico. There was a single, double-flue chimney for the parlor fireplaces and ^achimney in the kitchen.

The Jacob Conser House was acquired by the City of Jefferson on September 14, 1937. It is used as a city hall and library, and is well maintained and structurally sound. In 1939 the City remodeled the interior in cooperation with the Works Projects Administration. Work included removing some interior walls, replacing flooring, adding a new stairway, and installing shelves for the library. Much of the original finish work was retained, however, including the paneled walls and doors with three light transoms. The 1939 restoration of the exterior was not so radical. The only major change was the replacement of the front porch steps with concrete.

The most outstanding feature of the exterior is the recessed portico on the east facade. ~~This~~ ^{is} this feature which causes the house to be classified as a prime example of the so-called "saddle-bag" type. The portico has two free-standing fluted columns and two fluted half columns attached to the porch walls. The one and a half story porch measures 29' 4 1/2" by 7' 4". Small double-hung sash windows with three over three lights open from the second floor onto the portico. The plain boxed cornice with returns on the gable ends is "supported" ^{by} corner boards with simple capitals in imitation of pilasters. Original clapboard siding has been retained. Fenestration is regular. Double hung sash windows with six lights over six on the first floor have simple surrounds and slip sills. The house measures c. 55' by 55 feet. The wings are c. 34 feet wide.

In his article on Oregon architecture cited among the major bibliographical references, Professor Marion Ross suggests that the builders of the house were fairly experienced (Conser himself was trained as a millwright) and that they were provided with some of the popular pattern books of the day. He suggests that plates 13 and 14 in Edward Shaw's Rural Architecture published in Boston in 1843 may have offered the prototype.

STATEMENT OF SIGNIFICANCE

The town of Jefferson on the Santiam River was originally known as Conser's Ferry. The founder, Jacob Conser, crossed the plains in 1848, acquired the improvements from a donation land claim near Scio, and the following year took up a half-section of land at what is now Jefferson and acquired an additional half-section that adjoined the claim. In 1853 he started a saw-mill, and a few years later erected a flour and grist mill.

Conser was born in Pennsylvania in 1818. He was bound out when a small boy, and not liking the man to whom he was bound, he ran away and made his way to Illinois, where he learned the millwright's trade. In 1849, shortly after he immigrated to Oregon, he was elected a member of the first Territorial Legislature. He was elected again in 1856. When he settled at what is now Jefferson, Santiam City was the post office and trading point for the district. After a flood in 1851, he devoted much time to the promotion of a new townsite on his claim upstream from Santiam City.

The first two houses to be built within the present limits of Jefferson were the log cabins of James Bates and Jacob Conser, town proprietor. Conser operated the ferry across the Santiam River at this point from 1851. In 1854 Jacob Conser built his town's first frame building, the subject of this nomination. It was a residence and hotel.

Conser involved himself in yet another enterprise when, in 1871, he joined in a partnership with Absalom Smith and a man named Culver to operate the Beaver Hosiery Manufacturing Co. which had been started a few years earlier by Smith.

When Jefferson Institute was organized at Conser's Ferry in 1856, Jacob Conser not only donated a large tract of land for the school, but also advanced money toward the construction of the building which was opened for use in 1858. It was this academic enterprise for which the town was eventually named.

In 1885 Conser retired from his varied business pursuits and moved to Eugene. He died there in 1894, at the age of 75, and his remains were returned to be buried in the town he founded.

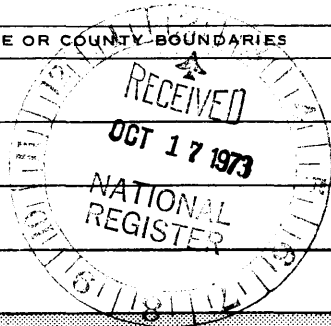
